

ALGEBRAIC HULLS AND SMOOTH ORBIT EQUIVALENCE

ABSTRACT. For $i = 1, 2$, let \mathcal{F}_i be foliations on smooth manifolds M_i determined by the actions of connected Lie groups H_i ; we describe here some results which provide an obstruction, in terms of a geometric invariant of the actions, to the existence of a diffeomorphism between the \mathcal{F}_i 's.

1. Introduction. Let (M_i, μ_i) , $i = 1, 2$, be two manifolds with quasi-invariant measures, and let $H_i \subset \text{Diff}(M_i)$ be connected Lie groups. If there is a measure class preserving diffeomorphism $\theta: M_1 \rightarrow M_2$ which is a bijection of H_1 -orbits and H_2 -orbits then we say that the actions are smoothly orbit equivalent. If the H_i -actions determine foliations \mathcal{F}_i on the manifolds M_i , then the map θ is just a diffeomorphism between the foliations. These phenomena, and the corresponding phenomena arising in situations in which the (M_i, μ_i) are just Borel (or topological) H_i -spaces and the map θ is a measure class preserving Borel isomorphism (or homeomorphism), have been studied, using a variety of techniques, independently by several authors ([B], [CFW], [D1], [D2], [K], [PnZ], [W1], [W2], [Z2], [Z4]) and most of the results obtained require some strengthening of the hypotheses, such as finiteness and invariance of the measures and amenability or semisimplicity (in higher rank) of the groups acting.

One of the results that we want to describe in this paper fits in this geometric setting and provides an obstruction, in terms of a geometric invariant of the actions, to the foliations being diffeomorphic. Recall that, if H acts ergodically and by diffeomorphisms on the n -dimensional manifold M , the algebraic hull of the H -action is the unique (up to conjugacy) smallest algebraic subgroup $L \subset \text{GL}(n, \mathbb{R})$, such that there exists a measurable H -invariant reduction to L of the frame bundle on M , on which H acts by automorphisms. (For an analytic definition see §2 and for the general context see [Z5, 9.2].) Then the normal algebraic hull of the H -action on M will be the projection of L in the direction normal to the orbits.

Theorem 4.1. *Let H_1, H_2 be connected Lie groups, $H_i \subset \text{Diff}(M_i)$, where M_i are smooth manifolds with a quasi-invariant measure μ_i . Suppose that the actions are locally free, essentially free (i.e. free on a conull set) and ergodic, and let \mathcal{F}_i be the corresponding foliations. If the \mathcal{F}_i are diffeomorphic, then the normal algebraic hulls are conjugate.*

Notice that there are no assumptions on the finiteness or the invariance of the measures; moreover, local freeness is necessary only to be able to state the theorem in terms of foliations (instead of orbits) and we require ergodicity only to state the result in terms of algebraic hulls globally and not restricting the attention to each ergodic component.

Many interesting examples arise as particular cases of homogeneous spaces G/Γ , where G is a connected, semisimple Lie group with no compact factors and Γ is a lattice in G ; the action of H will hence be via an embedding $H \hookrightarrow G$ and the foliation determined by the H -action will be identified with the double cosets $H \backslash G/\Gamma$. (Notice that, in this context, essential freeness of the H -action on $M = G/\Gamma$ follows automatically, at least in the case in which H is algebraic, as it is shown in Proposition 4.4.) This situation has been extensively studied, not only in the case in which G is semisimple, ([B], [M], [Pr], [Rt], [W1], [W2]). One of the most recent and complete results is due to Dave Witte, [W2]; generalizing an idea of D. Benardete, [B], he proved that any (continuous) orbit equivalence between two foliations $H_i \backslash G_i/\Gamma_i$ (where the G_i 's are semisimple groups to which the Mostow Rigidity theorem applies or suitable solvable groups or simply connected nilpotent groups) is the composition of an affine map and a homeomorphism that preserves each leaf, provided that the H_i 's are unimodular. (An affine map between G_1/Γ_1 and G_2/Γ_2 is the composition of a homomorphism $\sigma: G_1 \rightarrow G_2$, such that $\sigma(\Gamma_1) \subset \Gamma_2$, and a translation.) Our approach to the problem is completely different and, for this kind of actions, the next theorem provides an explicit way to compute the algebraic hulls.

Theorem 3.1. *Let G be a connected semisimple Lie group with no compact factors and finite center, $\Gamma \subset G$ an irreducible lattice and $H \subset G$ a non-compact closed subgroup. Then the algebraic hull of the H -action on G/Γ is the algebraic hull of $\text{Ad}_G(H)$.*

It is worth observing here that, building on Theorem 4.1 and 3.1, our methods give results for the group $H = ax + b \simeq \mathbb{R}^\times \ltimes \mathbb{R}$ of affine motions of the line which do not seem to be accessible so far by other techniques, (see §4 for details). Moreover, besides being of independent interest, this theorem gives also results in terms of smoothly conjugate actions. In fact we have the following:

Corollary 3.2'. *Let G, Γ be as above and let H be a non-compact Lie group acting on G/Γ via two different embeddings $\pi_1, \pi_2: H \rightarrow G$ with closed images H_1, H_2 . If the actions of H on G/Γ given by π_i 's are conjugate, then $\text{ad}_{\mathfrak{g}}(\mathfrak{h}_1)$ and $\text{ad}_{\mathfrak{g}}(\mathfrak{h}_2)$ are conjugate as subalgebras of $\mathfrak{gl}(\mathfrak{g})$.*

It needs to be recalled here that a much stronger result (even though with a narrower range of application in the semisimple case) has been proven by D. Witte, [W1]; he showed, in fact, that any measurable isomorphism of ergodic unipotent translations on G/Γ (where G is a connected Lie group and Γ is any closed subgroup of G such that G/Γ has finite volume) is an affine map, or, in other words, that H

and H_2 are conjugate in G . (A weaker conclusion holds in the case in which the H_i 's have zero-entropy.) In §3 we shall illustrate how to deal with some examples which can be approached both using our result and Witte's theorem.

The proof of these results are essentially based on two ingredients: the first is a correspondence in cohomology between the cocycle of the H -action and a cocycle of a suitable Γ -action, ([Z3] and Lemma 3.1); the second ingredient is the correspondence (under the necessary hypotheses) between the algebraic hull of a G -action and the algebraic hull of the restriction of the action to Γ , (Theorem 2.1). It should be noticed here that the necessity of restricting our attention to semisimple groups is due to the fact that Theorem 2.1 is known, so far, only in this case.

For completeness, although in a different spirit, we study also the case in which G is a compact Lie group, and the following theorem is proven in §3.

Theorem 3.4. *Let H, G be Lie groups with G compact and let $\pi_i: H \rightarrow G$, $i = 1, 2$, be two embeddings with dense image $\pi_i(H) = H_i$. If the actions of H_i 's on G are measurably conjugate, then there exists an automorphism A of G such that $A(H_1) = H_2$.*

2. Preliminaries on cocycles. Let (S, μ) be a G -space with a quasi-invariant measure μ , and let $\alpha, \beta: S \times G \rightarrow H$ be measurable cocycles. Recall that we say that α is equivalent to β , (and we write $\alpha \sim \beta$) if there exists a measurable map $\varphi: S \rightarrow H$ such that, for every $g \in G$, $\beta(s, g) = \varphi(gs)\alpha(s, g)\varphi(s)^{-1}$ for almost every $s \in S$. If G is ergodic on S and H is algebraic there exists a unique (up to conjugacy) smallest algebraic subgroup $L \subseteq H$ such that α is equivalent to a cocycle taking values in L , but is not equivalent to a cocycle taking value in a proper algebraic subgroup of L . It follows that if $\alpha \sim \beta$, $\beta(S \times G) \subseteq J$ and J is algebraic, then J contains a conjugate of L . The conjugacy class of L is called the algebraic hull of α , [Z5, 9.2]. Given any group G acting by diffeomorphisms on a smooth manifold M we define the algebraic hull of the G -action on M to be the algebraic hull of the derivative cocycle $\alpha: M \times G \rightarrow \text{GL}(n, \mathbb{R})$ defined as $\alpha(m, g) = (dg)_m$, after a measurable trivialization of the tangent bundle.

Let $\alpha_\Gamma: S \times \Gamma \rightarrow H$ denote the restriction of a cocycle α to Γ . The next result will be crucial in proving Theorems 3.1 and 4.1.

Theorem 2.1, [I]. *Let G be a connected semisimple Lie group with finite center and no compact factors, and let $\Gamma \subset G$ be an irreducible lattice. Let $\alpha: S \times G \rightarrow H$ be a cocycle of an ergodic G -action into an algebraic group and assume that the G -action of G on S is not essentially transitive with compact stabilizers. Then the algebraic hulls of α and α_Γ are the same.*

Recall that under the above hypotheses on G, Γ and S , the restriction to Γ of the G -action is still ergodic, [Mo], [Z1]; this implies in turn that the product action of G on $S \times G/\Gamma$ is ergodic as well, [Z3, Proposition 2.2.2].

Let $Z(S \times G; H)$ be the set of cocycles from $S \times G$ into H and let $H^1(S \times G; H)$ be the set of the corresponding equivalence classes of cocycles.

Proposition 2.2. *Let G, Γ, H and S be as above. Then there is a bijection in cohomology $\Psi: H^1(S \times \Gamma; H) \rightarrow H^1(S \times G/\Gamma \times G; H)$ which preserves the algebraic hulls.*

Remark. The existence of the bijection holds in much greater generality, [Z3], for any closed subgroup Γ of a locally compact topological group G , any locally compact topological group H and any G -space S . However, besides the fact that the above situation is the one in which we shall use this result, the correspondence between algebraic hulls makes sense only under suitable hypotheses which insure ergodicity of all the actions.

Proof. Since we shall use it in the sequel, we give here the explicit form of this correspondence, leaving out the details. For a complete proof see [I], [Z3]. Let $\eta: G/\Gamma \rightarrow G$ be a Borel section of the canonical projection $p: G \rightarrow G/\Gamma$, such that $\eta(p(g))g \in \Gamma$ for every $g \in G$. Then, if $[\alpha] \in H^1(S \times \Gamma; H)$ and $\alpha \in Z(S \times \Gamma; H)$ with $\alpha \in [\alpha]$, we define $\Psi(\alpha)(s, x, g) = \alpha(\eta(x), \eta(gx)g\eta(x)^{-1})$; the equivalence class of $\Psi(\alpha)$ will be independent of the choice of $\alpha \in [\alpha]$ and hence Ψ will be a map in cohomology. Conversely, given $[\beta] \in H^1(S \times G/\Gamma \times G; H)$ and $\beta \in [\beta]$, we want to define $\Phi = \Psi^{-1}$; choose $x \in g[e] \in G/\Gamma$ and define $\Phi(\beta) \in Z(S \times \Gamma; H)$ as $\Phi(\beta)(s, \gamma) = \beta(gs, x, g\gamma g^{-1})$. Then $\Psi(\beta)$ is independent in cohomology of the choice of $x \in G/\Gamma$, Φ and Ψ are inverses in cohomology and both maps preserve the algebraic hulls. \square

Let (S_i, μ_i) be H_i -spaces, $i = 1, 2$; we say that the actions of H_1 and H_2 are orbit equivalent if there exists a measure class preserving Borel isomorphism (possibly after discarding a set of measure zero) $\theta: S_1 \rightarrow S_2$ that takes any H_1 -orbit onto an H_2 -orbit. If the H_2 -action is essentially free then the map θ defines a cocycle $\lambda: S_1 \times H_1 \rightarrow H_2$ which satisfies the relation $\theta(h_1 s_1) = \lambda(s_1, h_1)\theta(s_1)$. If the cocycle λ is equivalent to a cocycle independent of $s_1 \in S_1$, namely if $\lambda \sim \lambda_\rho$ where $\lambda_\rho(s_1, h_1) = \rho(h_1)$ with $\rho: H_1 \rightarrow H_2$ a homomorphism, then we say that the actions are conjugate (or isomorphic). If S_1 and S_2 are manifolds and the map θ is a diffeomorphism then we say that the actions are respectively smoothly orbit equivalent and smoothly conjugate (or smoothly isomorphic); moreover, in the essentially free case, the cocycle λ will be smooth along a.e. orbit. The correspondence in cohomology described in the next Proposition is well known, [Rm], and we shall use this result several times in the following.

Proposition 2.3. *If $\theta: S_1 \rightarrow S_2$ is an orbit equivalence between essentially free spaces, then there is a bijection $\Upsilon: Z(S_2 \times H_2; L) \rightarrow Z(S_1 \times H_1; L)$ which is a bijection in cohomology and preserves the algebraic hulls.*

Proof. If $\beta \in Z(S_2 \times H_2; L)$, let us define $\tilde{\beta} \in Z(S_1 \times H_1; L)$ as $\tilde{\beta}(s_1, h_1) = \Upsilon(\beta)(s_1, h_1) = \beta(\theta(s_1), \lambda(s_1, h_1))$, where $\lambda: S_1 \times H_1 \rightarrow H_2$ is the cocycle associated to θ . Conversely, if $\alpha \in Z(S_1 \times H_1; L)$ let us define $\Xi(\alpha) = \alpha_0 \in Z(S_2 \times H_2; L)$ as $\alpha_0(s_2, h_2) = \alpha(\theta^{-1}(s_2), \eta(s_2, h_2))$, where $\eta: S_2 \times H_2 \rightarrow H_1$ is the cocycle associated to θ^{-1} , namely if $\lambda(s_1, h_1) = h_2$ and $\theta(s_1) = s_2$, then $\eta(s_2, h_2) = \eta(\theta(s_1), \lambda(s_1, h_1)) = h_1$. It is straightforward to verify that the maps Ξ and Υ are inverses and that equivalence classes of cocycles, as well as algebraic hulls, are preserved. \square

3. Smoothly conjugate actions. Let G be a connected semisimple Lie group with no compact factors, finite center and Lie algebra \mathfrak{g} and let Γ be an irreducible lattice in G . Let H be a non-compact Lie group and let $\pi_1, \pi_2: H \rightarrow G$ be two different embeddings of H with closed images $H_i = \pi_i(H)$, $i = 1, 2$.

The first result we want to prove will be a very easy consequence of the next theorem which illustrates how to compute the algebraic hull of the H -action on G/Γ by diffeomorphisms, where, for simplicity of notation, we identify H with its embedded image in G .

Recall that since Γ is discrete, the tangent bundle $T(G/\Gamma)$ can be smoothly identified with $G/\Gamma \times \mathfrak{g}$. Then the action of $H \subset G \subset \text{Diff}(G/\Gamma)$ on $T(G/\Gamma)$ is given, via this identification, by the derivative cocycle $\alpha: G/\Gamma \times H \rightarrow \text{GL}(\mathfrak{g})$, $\alpha(x, h) = (dh)_x = \text{Ad}_G(h)$, for $x \in G/\Gamma$ and $h \in H$.

Theorem 3.1. *Let G be a semisimple non-compact Lie group with no compact factors and finite center, $\Gamma \subset G$ an irreducible lattice and $H \subset G$ a non-compact closed subgroup. Then the algebraic hull of the H -action on G/Γ is the algebraic hull of $\text{Ad}_G(H)$.*

Before proving this theorem note the following consequence.

Corollary 3.2. *Let G, Γ, H_i , $i = 1, 2$, be as above. If the H_1 -action and the H_2 -action on G/Γ are smoothly isomorphic then the algebraic hulls of $\text{Ad}_G(H_1)$ and $\text{Ad}_G(H_2)$ are conjugate as subgroups of $\text{GL}(\mathfrak{g})$.*

Remarks. 1) If H is a non-compact connected simple Lie group, the result of Theorem 3.1 is in [Z6, Corollary 5.3], and is a consequence of the Borel Density theorem.

2) A natural question is to ask whether or not Theorem 3.1 is true for subgroups Γ which are only Zariski dense. In our theorem, we need the hypothesis of Γ being a lattice, because this was the case in which, so far, we have been able to prove Theorem 2.1, (cf. §1).

3) If the H_i 's are real algebraic, as in the case in which H is real algebraic and the π_i 's are rational homomorphisms, then $\text{Ad}_G(H_i)$ is of finite index in a real algebraic group, so that the conclusion of the Corollary is that, (modulo a finite group), $\text{Ad}_G(H_1)$ and $\text{Ad}_G(H_2)$ are conjugate in $\text{GL}(\mathfrak{g})$.

The following is just a local reformulation of the previous Corollary.

Corollary 3.2'. *Let G, Γ, H_i , $i = 1, 2$, be as above. If the H_1 -action and the H_2 -action on G/Γ are smoothly isomorphic then $\text{ad}_{\mathfrak{g}}(\mathfrak{h}_1)$ and $\text{ad}_{\mathfrak{g}}(\mathfrak{h}_2)$ are conjugate in $\mathfrak{gl}(\mathfrak{g})$.*

Proof of Corollary 3.2. Let $\alpha_i: G/\Gamma \times H_i \rightarrow \text{GL}(\mathfrak{g})$ be the derivative cocycles $\alpha_i(x, h_i) = (dh_i)_x$, for $x \in G/\Gamma$ and $h_i \in H_i$. Because of the isomorphism θ between the H_1 and the H_2 -action, we have that for a.e. $x \in G/\Gamma$, $\theta(h_1x) = h_2\theta(x)$, where $h_2 = \rho(h_1)$. Differentiation of this equality yields the relation $(d\theta)_{h_1x}(dh_1)_x(d\theta)_x^{-1} = (dh_2)_{\theta(x)}$ or else $\varphi(h_1x)\alpha_1(x, h_1)\varphi(x)^{-1} = \alpha_2(\theta(x), h_2)$, where $\varphi: G/\Gamma \rightarrow \text{GL}(\mathfrak{g})$ is defined as $\varphi(x) = (d\theta)_x$: hence $\alpha_2 = \Upsilon^{-1}(\alpha_1)$ (as defined in Proposition 2.3), so that the algebraic hulls of α_1 and α_2 are the same. \square

Proof of Theorem 3.1. As it is shown in Proposition 2.2, and with the same notation, we have the bijections $H^1(G/\Gamma \times H; \text{GL}(n, \mathbb{R})) \leftrightarrow H^1(G/\Gamma \times G/H \times G; \text{GL}(n, \mathbb{R}))$ and $H^1(G/H \times G/\Gamma \times G; \text{GL}(n, \mathbb{R})) \leftrightarrow H^1(G/H \times \Gamma \backslash \text{GL}(n, \mathbb{R}))$ which together

with the obvious identification $H^1(G/\Gamma \times G/H \times G; \mathrm{GL}(n, \mathbb{R})) \simeq H^1(G/H \times G/\Gamma \times G; \mathrm{GL}(n, \mathbb{R}))$ imply that there is a bijection in cohomology between cocycles for the H -action on G/Γ and cocycles for the Γ -action on G/H , and this bijection preserves the algebraic hulls. However, for our purpose, we need to study the correspondence more closely; in particular, we need to see that the cocycle $\beta_\Gamma: G/H \times \Gamma \rightarrow \mathrm{GL}(n, \mathbb{R})$ corresponding to $\alpha: G/\Gamma \times H \rightarrow \mathrm{GL}(n, \mathbb{R})$, where $\alpha(x, h) = (dh)_x = \mathrm{Ad}_G(h)$ is the adjoint cocycle, is still the restriction to Γ of the adjoint representation of G . If we can prove this we are done, because then by Theorem 2.1 the algebraic hull of $\beta_\Gamma: G/H \times \Gamma \rightarrow \mathrm{GL}(n, \mathbb{R})$ is the same as the algebraic hull of $\beta: G/H \times G \rightarrow \mathrm{GL}(n, \mathbb{R})$ and, by transitivity of G on G/H , this is the same as the algebraic hull of $\mathrm{Ad}_G(H)$, [Z5, Proposition 4.2.13]. Hence to complete the proof we need to show the following:

Lemma 3.3. *Let H, Γ be closed subgroups of G and let $\alpha: G/\Gamma \times H \rightarrow L$ be the cocycle $\alpha(x, h) = \pi(h)$ where $\pi: G \rightarrow L$ is a given homomorphism. Let $[\beta] \in H^1(G/H \times \Gamma; L)$ be defined as $[\beta] = \Omega([\alpha])$, where Ω is the bijection $\Omega: H^1(G/\Gamma \times H; L) \rightarrow H^1(G/H \times \Gamma; L)$. Then there exists a cocycle $\beta \in [\beta]$ such that $\beta(y, \gamma) = \pi(\gamma)$.*

Proof. We shall use the same notation as in Proposition 2.2, writing however $H(G/\Gamma \times H)$ and $H(G/H \times \Gamma)$ for $H(G/\Gamma \times H; L)$ and $H(G/H \times \Gamma; L)$, respectively. Let $p: G \rightarrow G/H$ be the canonical projection and let $\sigma: G/H \rightarrow G$ be a Borel section such that $\sigma(p(g))g \in H$ for every $g \in G$. Then we have the map

$$\begin{array}{ccc} \Psi: H^1(G/\Gamma \times H) & \longrightarrow & H^1(G/\Gamma \times G/H \times G) \\ \alpha & \longmapsto & \alpha^0 \end{array}$$

defined as $\alpha^0(x, y, g) = \alpha(\sigma(y)x, \sigma(gy)g\sigma(y)^{-1}) = \pi(\sigma(gy)g\sigma(y)^{-1})$ and the map

$$\begin{array}{ccc} \Phi: H^1(G/H \times G/\Gamma \times G) & \longrightarrow & H^1(G/H \times \Gamma) \\ \beta & \longmapsto & \beta_x \end{array}$$

defined as $\beta_x(y, \gamma) = \beta(gy, x, g\gamma g^{-1})$, where $x = g[e]_\Gamma \in G/\Gamma$. Notice that Φ is independent in cohomology of the choice of x . Moreover if

$$\begin{array}{ccc} \Sigma: H^1(G/\Gamma \times G/H \times G) & \longrightarrow & H^1(G/H \times G/\Gamma \times G) \\ \alpha & \longmapsto & \tilde{\alpha} \end{array}$$

is the identification $\Sigma(\alpha)(x, y, g) = \tilde{\alpha}(x, y, g) = \alpha(y, x, g)$, where $x \in G/\Gamma$, $y \in G/H$, looking at the composition $\Omega = \Psi \circ \Sigma \circ \Phi$ of these maps

$$\begin{array}{ccccccc} H^1(G/\Gamma \times H) & \xrightarrow{\Psi} & H^1(G/\Gamma \times G/H \times G) & \xrightarrow{\Sigma} & H^1(G/H \times G/\Gamma \times G) & \xrightarrow{\Phi} & H^1(G/H \times \Gamma) \\ \alpha & \longmapsto & \alpha^0 & \longmapsto & \tilde{\alpha}^0 & \longmapsto & \tilde{\alpha}_x^0 \end{array} \blacksquare$$

we claim that $[\tilde{\alpha}_x^0] = [\alpha_\pi]$. In fact if $x = g[e]_\Gamma \in G/\Gamma$, for a.e. $y \in G/H$, for $\gamma \in \Gamma$

$$\begin{aligned} \tilde{\alpha}_x^0(y, \gamma) &= \tilde{\alpha}^0(gy, x, g\gamma g^{-1}) = \alpha^0(x, gy, g\gamma g^{-1}) = \\ &= \alpha(x\sigma(gy), \sigma(g\gamma y)g\gamma g^{-1}\sigma(gy)^{-1}) = \\ &= \pi(\sigma(g\gamma y)g\gamma g^{-1}\sigma(gy)^{-1}) = \\ &= \pi(\sigma(g\gamma y)g)\pi(\gamma)\pi(g^{-1}\sigma(gy)^{-1}) = \\ &= \pi(\sigma(g\gamma y)g)\pi(\gamma)\pi(\sigma(gy)g)^{-1} = \end{aligned}$$

where $\varphi_x: G/H \rightarrow L$ defined by $\varphi_x(y) = \pi(\sigma(gy)g)$ is the map which implements the equivalence. \square

Example. We want to point out that Corollary 3.2 allows us to obtain, by completely different methods, results which were already available via other techniques. For example, if $G = \mathrm{SL}(3, \mathbb{R})$ and $\Gamma \subset G$ is any lattice, let us consider the actions on G/Γ of the two unipotent one-parameter subgroups $H_i = \{\exp(tA_i) : t \in \mathbb{R}\}$, where

$$A_1 = \begin{pmatrix} 0 & 0 & 1 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{pmatrix} \quad \text{and} \quad A_2 = \begin{pmatrix} 0 & 1 & 0 \\ 0 & 0 & 1 \\ 0 & 0 & 0 \end{pmatrix}.$$

Since $\mathrm{ad}_{\mathfrak{g}}(\mathfrak{h}_1)$ and $\mathrm{ad}_{\mathfrak{g}}(\mathfrak{h}_2)$ have different rank (as linear transformations of \mathfrak{g}) then they cannot be conjugate in $\mathfrak{gl}(\mathfrak{g})$, thus implying that the actions of \mathbb{R} by the identification with the H_i 's cannot be isomorphic. The same result is a consequence of Witte's theorem, [W1], since H_1 and H_2 are not conjugate in G as well. (If they were, then A_1 and A_2 would be conjugate matrices in \mathfrak{g} , which is impossible, since they have different rank.)

Before studying actions which are just smoothly orbit equivalent, let us examine, in contrast with what done before, the case in which the group G is compact. Since for compact groups ergodicity is equivalent to (essential) transitivity [Z5, 2.1], then the restriction of the action to a subgroup H is still ergodic if and only if H is dense in G .

Theorem 3.4. *Let H, G be Lie groups with G compact and let $\pi_i: H \rightarrow G$, $i = 1, 2$, be two different embeddings with dense image $\pi_i(H) = H_i$. Suppose there exists a measurable bijection $\theta: G \rightarrow G$ which conjugates the H_i -actions, $i = 1, 2$. Then there exists an automorphism A of G such that $A(H_1) = H_2$.*

Remark. The same result holds also in the case in which H_i acts on G/G_0 where G_0 is not normal in G .

Proof. Since the H_1 -action and the H_2 -action on G are conjugate, we have that for a.e. $x \in G$, $h_2\theta(x) = \theta(h_1x)$, where $h_i = \pi_i(h)$, $i = 1, 2$. If we define a right action of $G \times G$ on $\mathrm{Map}(G, G) = \{f: G \rightarrow G \mid f \text{ is measurable}\}$ as $(f \cdot (g_1, g_2))(x) = g_2^{-1}f(g_1x)$, θ turns out to be a fixed point for the H -action, where H acts on $\mathrm{Map}(G, G)$ via $(\pi_1, \pi_2)(H) = H_1 \times H_2 \subset G \times G$. By continuity of the action, θ is left fixed also by the closure $\overline{H_1 \times H_2} = L$ of $H_1 \times H_2$ in $G \times G$. If $p_i: G \times G \rightarrow G$, $i = 1, 2$, is the projection onto the i -th coordinate, since $H_i \subset p_i(L) \subset \overline{H_i} = G$, we have that $p_i(L) = G$, $i = 1, 2$, that is L projects onto G on both coordinates. So for $(g_1, g_2) \in L$ we have that $(g_1, g_2)\theta = \theta$, that is $g_2\theta(x) = \theta(g_1x)$ for every $x \in G$. Notice that, since the action is free, g_2 is uniquely determined by g_1 : in other words there exists a unique $g_2 = \lambda(g_1)$ such that $(g_1, \lambda(g_1)) \in L$. Moreover since $\lambda(g_1g_2)\theta(x) = \theta(g_1g_2x) = \lambda(g_1)\theta(g_2x) = \lambda(g_1)\lambda(g_2)\theta(x)$, then $\lambda \in \mathrm{Aut}(G)$. \square

4. Smooth orbit equivalence. If H is a connected Lie group acting by diffeomorphisms on a smooth manifold M with discrete stabilizers, then the H -orbits determines a foliation \mathcal{F} on M and smoothly orbit equivalent actions corresponds to diffeomorphic foliations.

Theorem 4.1. *Let H_1, H_2 be connected Lie groups acting by diffeomorphisms on smooth n -dimensional manifolds M_1, M_2 . Suppose that the H_i -actions are essentially free, locally free and ergodic, and let $\mathcal{F}_1, \mathcal{F}_2$ be the corresponding foliations on M_1, M_2 . If the foliations are diffeomorphic then the algebraic hulls of the derivative cocycles in the direction normal to the leaves of the foliations are conjugate.*

Proof. Since $\mathcal{F}_1, \mathcal{F}_2$ are smoothly equivalent, then there is a diffeomorphism $\theta: M_1 \rightarrow M_2$ such that, for every $m \in M_1, h_1 \in H_1$, $\theta(h_1 m) = h_2 \theta(m)$, with $h_2 = \lambda(m, h_1) = \lambda_{h_1}(m)$, where $\lambda: M_1 \times H_1 \rightarrow H_2$ is a cocycle a.e. smooth along the orbits. If we write the previous equation as $\theta \circ L_{h_1}(m) = L_{\lambda(m, h_1)} \circ \theta(m)$, where $L_h(m) = hm$ denotes the action on m by the diffeomorphism defined by h , and we let $\rho_{m_i}: H_i \rightarrow M_i$ denote the orbit map $\rho_{m_i}(h_i) = h_i m_i$ for $m_i \in M_i$, then differentiation of the above expression at m for $h_1 \in H_1$ fixed gives

$$\begin{aligned} (d\theta)_{h_1 m}(dL_{h_1})_m &= d(\theta \circ L_{h_1})_m = d(L_{\lambda(m, h_1)} \circ \theta)_m = \\ &= (dL_{\lambda(m, h_1)})_{\theta(m)}(d\theta)_m + (d\rho_{\theta(m)})_{\lambda(m, h_1)}(d\lambda_{h_1})_m \end{aligned}$$

which shows that the diagram

$$\begin{array}{ccc} T_m M_1 & \xrightarrow{(dL_{h_1})_m} & T_{h_1 m} M_1 \\ (d\theta)_m \downarrow & & \downarrow (d\theta)_{h_1 m} \\ T_{\theta(m)} M_2 & \xrightarrow{(dL_{\lambda(m, h_1)})_{\theta(m)}} & T_{h_2 \theta(m)} M_2 = T_{\theta(h_1 m)} M_2 \end{array}$$

does not necessarily commute. However, the maps $L_{h_1}, L_{\lambda(m, h_1)}$ and θ preserve the foliations and their derivatives $dL_{h_1}, dL_{\lambda(m, h_1)}, d\theta$ preserve the tangent space to the foliations, that is

$$T_m \mathcal{F}_1 \xrightarrow{(dL_{h_1})_m} T_{h_1 m} \mathcal{F}_1 \xrightarrow{(d\theta)_{h_1 m}} T_{\theta(h_1 m)} \mathcal{F}_2$$

and

$$T_m \mathcal{F}_1 \xrightarrow{(d\theta)_m} T_{\theta(m)} \mathcal{F}_2 \xrightarrow{(dL_{\lambda(m, h_1)})_{\theta(m)}} T_{h_2 \theta(m)} \mathcal{F}_2.$$

Hence we have the induced diagram

$$\begin{array}{ccc} T_m M_1 / T_m \mathcal{F}_1 & \xrightarrow{(dL_{h_1})_m} & T_{h_1 m} M_1 / T_{h_1 m} \mathcal{F}_1 \\ (d\theta)_m \downarrow & & \downarrow (d\theta)_{h_1 m} \\ T_{\theta(m)} M_2 / T_{\theta(m)} \mathcal{F}_2 & \xrightarrow{(dL_{\lambda(m, h_1)})_{\theta(m)}} & T_{h_2 \theta(m)} M_2 / T_{h_2 \theta(m)} \mathcal{F}_2 = T_{\theta(h_1 m)} M_2 / T_{\theta(h_1 m)} \mathcal{F}_2 \end{array}$$

which, if we denote by $N_m \mathcal{F}_i = T_m M_i / T_m \mathcal{F}_i$ the normal space to the foliation \mathcal{F}_i at the point m , becomes

$$\begin{array}{ccc} N_m \mathcal{F}_1 & \xrightarrow{(dL_{h_1})_m} & N_{h_1 m} \mathcal{F}_1 \\ (*) \quad (d\theta)_m \downarrow & & \downarrow (d\theta)_{h_1 m} \\ N_{\theta(m)} \mathcal{F}_2 & \xrightarrow{(dL_{\lambda(m, h_1)})_{\theta(m)}} & N_{h_2 \theta(m)} \mathcal{F}_2 = N_{\theta(h_1 m)} \mathcal{F}_2 \end{array}$$

Now we need the following

Lemma 4.2. $(d\lambda_{h_1})|_{N_m \mathcal{F}_1} = 0$ and the diagram $(*)$ commutes.

Assuming this Lemma, whose proof we postpone for a while, we have that

$$(d\theta)|_{N_{h_1 m} \mathcal{F}_1} (dL_{h_1})|_{N_m \mathcal{F}_1} = (dL_{\lambda(m, h_1)})|_{N_{\theta(m)} \mathcal{F}_2} (d\theta)|_{N_m \mathcal{F}_1} = (dL_{h_2})|_{N_{\theta(m)} \mathcal{F}_2} (d\theta)|_{N_m \mathcal{F}_1} \blacksquare$$

that is

$$(d\theta)|_{N_{h_1 m} \mathcal{F}_1} (dL_{h_1})|_{N_m \mathcal{F}_1} (d\theta)^{-1}|_{N_m \mathcal{F}_1} = (dL_{h_2})|_{N_{\theta(m)} \mathcal{F}_2}.$$

Using again Proposition 2.3 we can easily deduce that the algebraic hulls of $(dL_{h_1})|_{N_m \mathcal{F}_1}$ and $(dL_{h_2})|_{N_{\theta(m)} \mathcal{F}_2}$ are the same. In fact, if k and n ($k < n$) are the dimensions of the foliations and the manifolds respectively, let $\alpha_i \in Z(M_i \times H_i; \text{GL}(n - k, \mathbb{R}))$ be defined as $\alpha_i(m_i, h_i) = (dL_{h_i})|_{N_{m_i} \mathcal{F}_i}$, $i = 1, 2$. Since, by Proposition 2.3 (and using the same notation), we have that the algebraic hulls of $\Upsilon(\alpha_2)$ and α_2 are the same, it will be enough to show that $\Upsilon(\alpha_2) = \alpha_1$ in cohomology. In fact

$$\begin{aligned} \Upsilon(\alpha_2)(m, h_1) &= \alpha_2(\theta(m), \lambda(m, h_1)) = (dL_{h_2})|_{N_{\theta(m)} \mathcal{F}_2} = \\ &= (d\theta)|_{N_{h_1 m} \mathcal{F}_1} (dL_{h_1})|_{N_m \mathcal{F}_1} (d\theta)^{-1}|_{N_m \mathcal{F}_1} = \\ &= (d\theta)|_{N_{h_1 m} \mathcal{F}_1} \alpha_1(m, h_1) (d\theta)^{-1}|_{N_m \mathcal{F}_1} = \alpha_1'(m, h_1) \end{aligned}$$

where $\alpha_1 \sim \alpha_1'$ via the map $\phi: M_1 \rightarrow \text{GL}(n - k, \mathbb{R})$ defined as $\phi(m) = (d\theta)|_{N_m \mathcal{F}_1}$. Hence $[\Upsilon(\alpha_2)] = [\alpha_1]$ and this completes the proof. \square

Proof of Lemma 4.2. We want to differentiate the equation $\theta(h_1 m) = h_2 \theta(m)$ in local coordinates. Observe first of all that we can choose coordinate charts $\{(U_m, \varphi_m)\}_{m \in M_1}$, $\{(V_{m'}, \psi_{m'})\}_{m' \in M_2}$ on M_1 and M_2 such that the map $\theta: M_1 \rightarrow M_2$ is locally just the identity map. In fact let $\{(U_m, \varphi_m)\}_{m \in M_1}$ be charts which realize the foliation \mathcal{F}_1 , namely $\varphi_m((H_1\text{-orbit}) \cap U_m) = \{\mathbb{R}^k \times \varphi_m(U_m)\} \times \{\text{pt}\}$, and assume for simplicity that $\varphi_m(m) = (0, 0)$. We can choose charts $\{(V_{m'}, \psi_{m'})\}$ on M_2 defined as $(V_{m'}, \psi_{m'}) = (V_{\theta(m)}, \psi_{\theta(m)}) = (\theta(U_m), \varphi_m \circ \theta^{-1})$ and it is straightforward to check that these charts realize the foliation \mathcal{F}_2 , $\psi_{m'}(m') = (\varphi_m \circ \theta^{-1})(\theta(m)) = (0, 0)$ and locally the map $\theta_m: \varphi_m(U_m) \rightarrow \psi_{\theta(m)}(V_{\theta(m)}) = \varphi_m(U_m)$ defined as $\theta_m = \psi_{\theta(m)} \circ \theta \circ \varphi_m^{-1}$ is just the identity. Fix $m_0 \in M_1$; if $m \in U_{m_0}$, $h_1 \in H_1$, we have that $h_1 m \in U_{h_1 m_0}$ so that $\varphi_{m_0}(m) = (x, y)$ and $\varphi_{h_1 m_0}(h_1 m) = (\tau_{h_1}(x, y), \xi(y))$ where $\tau_{h_1}: \mathbb{R}^k \times \mathbb{R}^{n-k} \rightarrow \mathbb{R}^k$ is just the map which describes in local coordinates the translation of m along the fiber by $h_1 \in H_1$ (i.e. $\tau_{h_1} = L_{h_1}$ in local coordinates), and $\xi: \mathbb{R}^{n-k} \rightarrow \mathbb{R}^{n-k}$ indicates in local coordinates the fiber of the point $h_1 m$ (notice that if $h_1 \in H_1$ is close enough to the identity so that $h_1 m \in U_{m_0}$, then $\xi(y) = y$). Moreover, because of our choice of charts on M_2 , since $\theta(m) \in \theta(U_{m_0}) = V_{\theta(m_0)}$ and $h_2 \theta(m) = \theta(h_1 m) \in \theta(U_{h_1 m_0}) = V_{\theta(h_1 m_0)}$, we can write $\psi_{\theta(m_0)}(\theta(m)) = (x, y)$ and $\psi_{\theta(h_1 m_0)}(h_2 \theta(m)) = (\tau_{h_2}(x, y), \eta(y))$ where τ_{h_2}, η describe in local coordinates (as observed above for τ_{h_1} and ξ) the action of h_2 on $\theta(m)$, and here $h_2 = \lambda(m, h_1)$ is a function of m . Then these equations together give us that

$$\begin{aligned} (\tau_{h_2}(x, y), \eta(y)) &= \psi_{\theta(h_1 m_0)}(h_2 \theta(m)) = \psi_{\theta(h_1 m_0)}(\theta(h_1 m)) = \\ &= \psi_{\theta(h_1 m_0)}(\theta(\varphi_{h_1 m_0}^{-1}(\tau_{h_1}(x, y), \xi(y)))) = \\ &= \psi_{\theta(h_1 m_0)}(\tau_{h_1}(\varphi_{h_1 m_0}^{-1}(\tau_{h_1}(x, y), \xi(y)))) \end{aligned}$$

From these equalities it follows that $\xi = \eta$ and $(\tau_{h_2}(x, y), \xi(y)) = (\tau_{h_1}(x, y), \xi(y))$. Differentiation of this equality, using the notation $\tau_{h_j}^i(x, y) = \left. \frac{\partial \tau_{h_j}(u_1, u_2)}{\partial u_i} \right|_{(x, y)}$ and $\tau_{h_2}(x, y) = \zeta_{(x, y)}(h_2)$ (i.e. $\zeta_{(x, y)} = \rho_m$ in local coordinates), gives

$$\begin{aligned} \begin{pmatrix} \tau_{h_1}^1(x, y) & \tau_{h_1}^2(x, y) \\ 0 & \frac{\partial \xi}{\partial y} \end{pmatrix} &= \begin{pmatrix} \tau_{h_2}^1(x, y) + \frac{d\zeta_{(x, y)}}{dh_2} \frac{\partial \lambda}{\partial x} & \tau_{h_2}^2(x, y) + \frac{d\zeta_{(x, y)}}{dh_2} \frac{\partial \lambda}{\partial y} \\ 0 & \frac{\partial \xi}{\partial y} \end{pmatrix} = \\ &= \begin{pmatrix} \tau_{h_2}^1(x, y) & \tau_{h_2}^2(x, y) \\ 0 & \frac{\partial \xi}{\partial y} \end{pmatrix} + \frac{d\zeta_{(x, y)}}{dh_2} \begin{pmatrix} \frac{\partial \lambda}{\partial x} & \frac{\partial \lambda}{\partial y} \\ 0 & 0 \end{pmatrix} \end{aligned}$$

which is nothing but the expression in local coordinates of the equation

$$(d\theta)_{h_1 m} (dL_{h_1})_m = (dL_{\lambda(m, h_1)})_{\theta(m)} (d\theta)_m + (d\rho_{\theta(m)})_{\lambda(m, h_1)} (d\lambda_{h_1})_m.$$

But this shows that $(d\lambda)|_{N_m \mathcal{F}_1} = 0$ which implies the commutativity of the diagram (*). \square

In order to apply Theorem 4.1 we need the following:

Proposition 4.3. *Let $G(k, n-k) = \begin{pmatrix} GL(k, \mathbb{R}) & * \\ 0 & GL(n-k, \mathbb{R}) \end{pmatrix} \subset GL(n, \mathbb{R})$ and consider the surjective homomorphism $p: G(k, n-k) \rightarrow GL(n-k, \mathbb{R})$. Suppose $\alpha: G \times S \rightarrow G(k, n-k)$ is a cocycle with algebraic hull $H \subseteq G(k, n-k)$. Then the algebraic hull of $p \circ \alpha$ is the Zariski closure of $p(H)$ in which $p(H)$ is of finite index.*

Proof. Since p is surjective, the algebraic hull of $p \circ \alpha$ cannot be strictly contained in $p(H)$. Let $H_{\mathbb{C}}$ be a complex algebraic group defined over \mathbb{R} such that $H = (H_{\mathbb{C}})_{\mathbb{R}}$ consists of its real points. Since p is \mathbb{R} -regular, we have that $p(H_{\mathbb{C}})$ is an \mathbb{R} -algebraic group, but $p(H)$ is not necessarily Zariski closed. However if we denote by $\overline{p(H)}^Z$ the Zariski closure of $p(H)$ in $GL(n-k, \mathbb{R})$, we have the inclusions $p(H) \subset \overline{p(H)}^Z \subset (p(H_{\mathbb{C}}))_{\mathbb{R}}$: since $p(H) = p((H_{\mathbb{C}})_{\mathbb{R}})$ is of finite index in $(p(H_{\mathbb{C}}))_{\mathbb{R}}$, it follows that $p(H)$ is of finite index in $\overline{p(H)}^Z$ as well. \square

The main application for the theorem about smooth orbit equivalence that we present here is to the H_i -action on G/Γ and we shall illustrate with an example at the end of this section how to obtain results which did not seem to be accessible by other methods. However, before doing this we want to show how in this case essential freeness follows almost automatically.

Proposition 4.4. *Let G be a non-compact connected simple Lie group, $\Gamma \subset G$ a lattice and $H \subset G$ an almost connected real algebraic group. Then H acts essentially freely on G/Γ .*

Remark. For simplicity we stated the result only for simple groups; however exactly the same proof works in the case in which G is semisimple and $\Gamma \subset G$ is irreducible, as long as we assume that Γ does not intersect a subgroup $N \subseteq H$ normal in G . Moreover, small modifications of the proof show that the result holds also in the case in which H is not algebraic.

We start the proof with the following lemma

Lemma 4.5. *Essential freeness of H acting on G/Γ is equivalent to essential freeness of Γ acting on G/H .*

Proof. This is just a straightforward exercise on double cosets. If μ is the Haar measure on G , let μ_Γ and μ_H be the measures respectively on G/Γ and G/H . Notice that, since G is connected and H is a proper subgroup of smaller dimension, if $X \subset G$ is a measurable subset then $\mu_\Gamma(p_\Gamma(X)) = 0$ if and only if $\mu(X) = 0$ if and only if $\mu_H(p_H(X)) = 0$, where we denote with $p_\Gamma: G \rightarrow G/\Gamma$ and $p_H: G \rightarrow G/H$ the canonical projections. Let $W = \{x\Gamma : \text{Stab}_H(x\Gamma) \neq e\} \subseteq G/\Gamma$ and $V = \{xH : \text{Stab}_\Gamma(xH) \neq e\} \subseteq G/H$. We want to show that $\mu_H(V) = 0$ if and only if $\mu_\Gamma(W) = 0$. An easy computation shows that for $x \in G$, $x\Gamma \in W$ if and only if $x^{-1}H \in V$, so that $p_H((\sigma_\Gamma(W))^{-1}) \subseteq V$, where $\sigma_\Gamma: G/\Gamma \rightarrow G$ is a section of the p_Γ . Hence $\mu_H(p_H((\sigma_\Gamma(W))^{-1})) \leq \mu_H(V)$. If $\mu_H(V) = 0$ then $\mu_H(p_H((\sigma_\Gamma(W))^{-1})) = 0$ so that $0 = \mu((\sigma_\Gamma(W))^{-1}) = \mu(\sigma_\Gamma(W)) = \mu_\Gamma(W)$ which is what we wanted: the other direction (which actually we shall not use), follows by symmetry. \square

Proof of 4.4. Because of the Lemma, it is enough to show that Γ is essentially free on G/H . With the notation used in 4.5 we need to show that $\mu_H(V) = 0$. For each $\gamma \in \Gamma$, let $V_\gamma = \{xH \in G/H : \gamma xH = xH\}$; it is clear that V_γ is a subvariety and that $V = \bigcup_{\gamma \in \Gamma} V_\gamma$, where the union is countable. Then it will be enough to show that, for every $\gamma \in \Gamma$, V_γ is a subvariety of smaller dimension, so that $\mu_H(V_\gamma) = 0$. Since G is connected, G/H is an irreducible variety, so that if V_γ does not have smaller dimension it must be $V_\gamma = G/H$. But if for some $\gamma_0 \in \Gamma$, $\gamma_0 \neq e$, we have $V_{\gamma_0} = G/H$, then, since $G/H = V_{\gamma_0} = gV_{\gamma_0} = V_{g\gamma_0g^{-1}}$ for any $g \in G$, this would imply the existence of a connected normal subgroup $N = G\gamma_0G^{-1}$ which is proper (since it fixes the whole space, hence $N \subseteq H$) and this is impossible since G is simple. \square

Example. Let $H = \mathbb{R}^\times \ltimes \mathbb{R}$ be the group of the affine motions of the line. If $\Gamma \subset \text{SL}(3, \mathbb{R})$ is any lattice let us consider the H -action on $\text{SL}(3, \mathbb{R})/\Gamma$ by $\pi_1, \pi_2: H \curvearrowright \text{SL}(3, \mathbb{R}) = G$ defined as

$$\pi_1(\lambda, t) = \begin{pmatrix} \lambda & 0 & t \\ 0 & \lambda^{-1} & 0 \\ 0 & 0 & 1 \end{pmatrix} \quad \text{and} \quad \pi_2(\lambda, t) = \begin{pmatrix} \lambda & 0 & t \\ 0 & \lambda & 0 \\ 0 & 0 & \lambda^{-2} \end{pmatrix}.$$

We claim that these two actions cannot be smoothly orbit equivalent, and we shall prove it by showing that $\text{Ad}_G(H_1)|_{\mathfrak{g}/\mathfrak{h}_1}$ and $\text{Ad}_G(H_2)|_{\mathfrak{g}/\mathfrak{h}_2}$ are not conjugate in $\text{GL}(\mathfrak{g})$. In fact, because of Theorem 3.1, we have that the algebraic hull of the H_i -action on G/Γ is the Zariski closure of $\text{Ad}_G(H_i)$ and Proposition 4.3 implies that the algebraic hull of the H_i -action in the direction normal to the orbits is the Zariski closure of $\text{Ad}_G(H_i)|_{\mathfrak{g}/\mathfrak{h}_i}$. Let $C_{\mathfrak{g}/\mathfrak{h}_i}(h_i)$ be the centralizer of $h_i \in H_i$ in $\mathfrak{g}/\mathfrak{h}_i$ and $V_{h_i} = \left\{ X \in \mathfrak{g}/\mathfrak{h}_i : \text{Ad}_G(h_i)|_{\mathfrak{g}/\mathfrak{h}_i} X = X \right\}$. Then we have that, for $h_i \in H_i$, $C_{\mathfrak{g}/\mathfrak{h}_i}(h_i) = V_{h_i}$, so that

$$C_{\mathfrak{g}/\mathfrak{h}_i}(H_i) = \bigcap_{h_i \in H_i} C_{\mathfrak{g}/\mathfrak{h}_i}(h_i) = \bigcap_{h_i \in H_i} V_{h_i} = V_{H_i}$$

An easy computation shows that $C_{\mathfrak{g}/\mathfrak{h}_1}(H_1)$ (and hence V_{H_1}) is zero-dimensional and

$C_{\mathfrak{g}/\mathfrak{h}_2}(H_2)$ (and hence V_{H_2}) consists of matrices of the form $\left\{ \begin{pmatrix} 0 & a & 0 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{pmatrix} : a \in \mathbb{R} \right\}$. Since $\text{Ad}_G(H_i)|_{\mathfrak{g}/\mathfrak{h}_i}$ is of finite index in its Zariski closure and since the dimension of the subspace of fixed vectors would be an invariant of conjugacy, it follows that the algebraic hulls of $\text{Ad}_G(H_1)|_{\mathfrak{g}/\mathfrak{h}_1}$ and $\text{Ad}_G(H_2)|_{\mathfrak{g}/\mathfrak{h}_2}$ cannot be conjugate in $\text{GL}(\mathfrak{g})$.
